# More than 150 College and University Presidents Tell Senators that Education is the Missing Link in Federal Climate Legislation

Presidents sent <u>letter</u> calling on the Senate to help prepare the American people for a clean energy economy by including in the climate bill funds for education - at all levels - to help Americans make well-informed decisions as consumers, workers, business-owners, and investors.





### Federal funding for College and University Sustainability Initiatives

Last year, the Higher Education Sustainability Act authorized \$50 million for the Department of Education to competitively award grants to colleges and universities development, implementation, and evaluation of sustainability curricula, practices and academic programs – but no funds have been appropriated for the University Sustainability Program (USP). Several colleges presidents have joined in a <u>letter</u> to Secretary Arne Duncan to urge the Department of Education to make funding for USP a priority in the President's FY 2011 Budget request to Congress. The statutory language authorizing USP grants is <u>here</u>.
